### THE AIM OF THESE AWARDS

All nominations will be judged using the following criteria. Your nomination does not need to meet all the criteria, each nomination will be based on its individual merit.

- Inclusivity – making sure everyone can be involved
- Inspiration - inspiring people to do more
- Innovation – new and exciting ways of delivering projects
- Lasting impact – will be around or make a difference for a long time
- Tackling issues that affect the people living in the Parish

### CATEGORIES

1. Individual (no age restriction)
2. Non-Profit Organisation/Voluntary Group

### NOMINATIONS

Nomination forms are available by downloading off the parish website, from the parish office or the village halls.

These should be sent to the Parish Council (post/email) by the deadline.

### DEADLINE FOR NOMINATIONS

Nominations must be received by 10<sup>th</sup> April 2020.

Presentations of awards will take place at the Parish Assembly to be held at Tanworth Village Hall on Wednesday 22<sup>nd</sup> April 2020.

### RULES

1. Nominees should live in the Parish, but discretion can be granted to people or organisations from outside Tanworth-in-Arden Parish if there has been clear and substantial benefit to the Parish.
2. A Parishioner is not eligible to receive an award every year for service rendered.
3. A Nomination must have a Proposer and a Secunder.
4. The decision of the Awards Panel is final.
5. Parish Councillors may not receive an award in their role as a councillor.
